The Webster Township Historical Society (WTHS) is a non-profit organization dedicated to preserving the landscape and historic structures built by early residents of Webster Township. All fees collected ensure the site remains one of Webster Township's most picturesque locations. Thank you for your support.

TERMS AND CONDITIONS OF USE

Those interested in shooting on location at WTHS and Historic Webster Village (HWV) may do so by adhering to the following conditions.

- All sessions must be scheduled in advance; call 734-726-5058 (messages are welcome and will be answered as soon as possible) or email WTHSmi@gmail.com
- Photographic sessions must take place between 9:00am and dusk EST/EDT. Access to the grounds is not permitted before or after these hours.
- Photographers and their party must check in at the Crossroads Community Center to receive their badge. Access badge will remain with the photographer and visible for the duration of the shoot.
- The photographer assumes full responsibility for the conduct of all persons in their party for any damage to any part of the site. The photographer agrees to pay for any damage that occurs during the session.
 - Refrain from damaging our buildings. Climbing on or swinging from any part of a building is strictly prohibited.
 - Refrain from damaging our grounds. Do not pick, cut, trim, or injure plants, flowers, trees or shrubs. Climbing on trees or fences is strictly prohibited.
- The log cabin next to our grounds is NOT WTHS property and may not be used for photography.
- Do not obstruct visitor walkways.
- Props and backdrops must be freestanding and not attached to any structures.
- Candles and open flames are not permitted on the grounds or in our buildings.
- Alcohol is prohibited.
- Any personal property brought onto the premises shall be at the sole risk of the photographer and WTHS shall not be liable for any loss or damage.
- Parking is restricted to the Crossroads Community Center or the north township public parking lot.
- WTHS reserves the right to deny a photographer permission to use our facilities or terminate a photographer's activity at any time for failure to comply with these terms.
